



## COMUNE DI RADDA IN CHIANTI

The Municipality of Radda in Chianti, by City Council decision n. 8 dated 19.03.2012, has established a City Tax and with C.C. resolution n. 7 of 08.01.2021 has approved the City Tax rates that will be applied for overnight stays at the accommodation facilities belonging to this municipality for the period from 1<sup>st</sup> July to 31<sup>st</sup> December 2021.

This tax was established in order to finance investments on tourism, including support to facilities, maintenance, use and recuperation of cultural property and local environment as well as local public services.

**WHO HAS TO PAY THIS TAX:** those overnighing in any of the facilities in this Municipality are required to pay the tax to the facility manager, who will provide a receipt.

**AMOUNT TO PAY:** The tax is to be paid per person and for each overnight stay as follows:

### EXEMPTIONS:

- a) registered residents of the Municipality of Radda in Chianti;
- b) minors under fourteen years of age;
- c) patients (including out-patients) and caregivers (one per patient) attending a patient recuperating in health facilities on municipal land;
- d) persons housed in facilities under resolution by public authorities in emergency situations as a consequence of disaster, force majeure or humanitarian aid;
- e) one guide and a bus driver for every group of 20 people;
- f) handicapped persons who are not self sufficient and a companion;
- g) employees of the facilities (hotels and similar)
- h) persons who stay for long periods for work reasons provided they have a certification signed by their employer who has an agreement with such facility that confirms the reason for their stay.

To enjoy the exemption it is necessary to fill out the corresponding application which is available at the facility's reception.
